

HOG ROAST TERMS & CONDITIONS

Our terms and conditions are there to protect both our customers and our company.
(Every booking will require a signed copy of our terms and conditions)

Please note you must have clear open access and no floors of stairs or have any kind of obstruction with access.

Our Hog Roast Machine is 54cm wide 90cm high and 194cm long.

We require an open area outside of 3 x 4 meter space for our gazebo and machine.

We will arrive and need access to your venue a minimum of 7 to 8 hours prior to serving time.
A power source is required onsite.

The Hog roast will have up to a 1.5 hour maximum serving window.

We do not take any leftovers with us. All leftovers will be placed in trays or plates provided by us.

We recommend having our equipment on grass. Should you require us to roast on any alternative surface and the Client will take full liability and responsibility for any damages that might occur during the event. Russell's Hog Roasts will not be liable for any damages that might occur.

We recommend setting up close to any clear exit point so once we are finished roasting as to avoid any disruption to your party when leaving.

We can only serve from our cooking position and cannot move the hog to other locations further away after cooking

To secure your event you will be required to pay a deposit of 25% . This can be paid to us via online banking or by card payment. Three weeks before your event all arrangements will be confirmed and the balance payable.
Please note all deposits are not refundable

All changes in catering numbers and /or menus need to be made 4 weeks prior to your function.

The Client needs to inform us of any and food allergies when making a booking.

We can only roast outdoors with our machines.

Fuel/Transport costs are Free within 15 miles of SG12 9DH after this there will be a £2.50 a mile charge one way added to the booking.

The customer is responsible for parking costs or congestion, emissions chargers on the day of the event. Should you not have a driveway, please secure a space for us in front of your property by parking your vehicle; this will avoid any delays or disruption towards your event upon arrival.

Russell's Hog Roasts is not responsible for any damage that may unintentionally occur.
We are covered and for third parties by our own public liability

By sending the booking form we send you back to us & paying your deposit you agree to all the terms above are correct and have been discussed with when booking.

Booking Confirmation

Once the Clients deposit has been received a receipt will be issued by Russell's Hog Roast together with a formal confirmation Email/letter which will include your event summary and estimated costs based on the number of guests and selections made by the Client at this time.

When filling out a booking form and paying a deposit you agree to all the terms & conditions that apply.

Force Majeure

Russell's Hog Roasts shall incur no liability to the Client if performance of the contract is prevented or hindered by any cause whatsoever beyond Russell's Hog Roast control and in particular but without prejudice to the generality of the foregoing, by act of fire, flood, subsidence, sabotage, accident, strike, or lock out and shall not be liable for any loss or damage resulting there from suffered by the Client.
